Persons actively engaged in the administration of student financial aid at any Minnesota post-secondary school may apply for regular membership. Regular members are eligible to vote, hold office and be committee members or chairs.

Persons associated with public and private organizations (including Minnesota post-secondary schools) that are concerned with or engaged in the support or administration of student financial aid may apply for associate membership. Associate members may serve on standing and ad hoc committees and task forces and will be permitted to chair ad hoc committees and task forces. Associate members shall not be entitled to vote, hold office or chair standing committees.

Persons who have retired from and have served in a position eligible for regular or associate membership in MAFAA may apply for retired membership. Retired members enjoy membership privileges at no charge, including receipt of the association newsletter and all other membership mailings. They may also attend MAFAA workshops and conferences at the regular member fee. Retired members may serve on ad hoc and standing committees and task forces. Retired members shall not be entitled to vote nor be appointed to chair a committee or task force.
