# No Stopping the Leadership Symposium

The 2019-20 Leadership group has been engaged with learning and growing and having fun over these past few months. The Leadership Symposium program was developed by MAFAA in 1994 to provide enhanced leadership skills and training for MAFAA members, which can then be applied to our work environment, personal life, and professional participation within the Association. In its symposiums, such topics as leadership style or preference, team building, goal setting, professional involvement, time management, personal development, and more are covered! # Outreach and Early Awareness Committee is asking — Can You Help?

# Is there someone in your office with expertise in assisting homeless youth or foster care youth navigate the financial aid process?

Completing the FAFSA is challenging for many students due to its complexity and length. Youth who are in crisis and/or may not have supportive adults in their lives may find it even more challenging.

Youth under age 24 who are experiencing homelessness or foster care may assume that they cannot pursue higher education because of their lack of resources and lack of parental support. They are unlikely to know that they have a special status on the FAFSA that allows them to apply for financial aid on their own.

The MAFAA Outreach and Early Awareness committee is collaborating with the Minnesota Office of Higher Education to develop resources to assist school district homeless liaisons and high school counselors serve Minnesota's homeless youth or foster care youth with the financial aid process.

Parking information is available on the directions and parking page of the Minnesota State Capitol website from the Minnesota Historical Society. The accessibility page of the Capitol website has links to accessible parking information and maps. Parking rates are listed on the parking page of the Minnesota State Capitol Restoration Project website.

Keep in mind that parking is very limited during the legislative session (January-May). You may want to consider public transportation. Both the Metro Transit bus line and the Green Line light rail have stops near the Capitol.

The MAFAA Day on the Hill was not able to take place as scheduled, though if you ever want to plan a visit after the stay-at-home orders related to the coronavirus pandemic are lifted, we recommend you start with "Visiting the Capitol" to get answers to all your questions.

In preparation for the next MAFAA membership year, I attended the 2020 NASFAA Leadership & Legislative Conference & Expo February 3<sup>rd</sup> and 4<sup>th</sup> in Washington, D.C. as your President-Elect-Elect. Also attending was your Treasurer-Elect-Elect Simon Bauer from St. Cloud State University.

It had been a long time since I attended a NASFAA event of any kind, so I didn't know what to expect regarding the quality of this event. I was registered for the Association Leadership Pathway Sessions and I am happy to say my time was well spent.

- Strategic Long-Range Planning
- Engaging Your Board and Getting to Consensus (Presidents-Elect/Presidents)
- Treasurer Fiduciary Responsibility (Treasurers)
- Volunteerism and Diversity
- State-Based Advocacy
- Creating a Plan of Action

Presenters included NASFAA professional leadership, the current and two previous National Chairs, as well as experts in the fields of non-profit board governance and advocacy. The sessions were very informative and delivered by folks with real world experience in state, regional, and national organizations. Reflecting on the guidance provided by NASFAA, there are many things MAFAA does well and a few which could use a little shoring up. The good news is those items are already being addressed by current organization leadership.

One topic that continued to surface as a concern for conference attendees was organization leadership succession. This hit home, as the last two MAFAA elections saw the President-Elect position on the ballot go unopposed. Now, I don't know how many votes "abstain" received, but having this situation in consecutive years fills me with concern. You see, I have an AARP card, as I am sure many of my contemporaries do. While this means I can get an occasional discount based solely on my age, this has major implications for MAFAA, as this group of chronologically superior members will not be around the profession all that much longer. We need to be mindful to actively develop members who are ready to take on this role.

My personal opinion is MAFAA is well positioned in this regard. I can look around the room at any MAFAA training event, meeting, or conference and see five to ten active members who could step into the role of President-Elect immediately. The issue, as I see it, is those same people may not see themselves in that same light. My aim is to work to change this.
